## ACTING CHAIRPERSON

No comment.

#### • MEMBER COMMENTS

- Mr. Peterson Caught me by surprise, no comment.
- Dr. Rice It was good to hear what Ed [Woods] had to say. For me when I hear that the work that we are doing with law enforcement, the fact that law enforcement is, from my perspective, at least I hope, are breaking down some of the walls they have and allowing mental health in. I think it works both ways as well. To me that is something we never had before except for the last couple years maybe. I question how much we really have that throughout the country, and not enough quite frankly. Also, it made me think about a police officer in Detroit that was shot and killed not long ago. While he was being shot at, his partner actually took her body and laid over his and took shots to try to protect him. The community came to the celebration of life because the community stood up stating that the police were there to protect them and that they saved their lives. There were people from all over the community. To me that is a testament that there are law enforcement officers out there that care, and they care about people, and they care about protecting people, and they do this for very little money and because it is a chosen profession, they want to do it. Are they all perfect, they are not, but the reality is, in this situation it is a tribute to two officers, one that died giving their life to protect people that they didn't even know. I just wanted to say that, thank you.
- Mr. Snell I can't follow up on that so no comment.
- Mr. Bohner No comment.
- Mr. Woods During our Mental Health in Schools Meeting, the folks that came from the Department of Education and someone from the UP, I forget the man's name, he mentioned several times that he was impressed with the coordination between our Community Mental Health and our school systems here. He wishes he could get the same kind of cooperation, and the same kind of joint work in other communities. When I think back on that, I think the original mental health in schools committee, Melissa appointed that committee, even going back further than that when I was over at 4th Street Learning Center, I got ahold of Maribeth and asked if she ever got to meet the school superintendent and she said no. I got ahold of the school superintendent, he said he never met Maribeth so we facilitated a meeting and from that this has all grown from "I don't know why we would have mental health services in schools" to what we've got going on today. There are a lot of people that, the gentleman at the MHIS meeting made very clear, they wished they had the same partnership in their school system. Also, one of the great things that happened during this

training with law enforcement is that one young officer mentioned that she ran into a specific incident on Jackson's south side, and Mayor Dan Mahoney said, "Maybe you should call me when that happens." The officer stated, "I don't have your number." He (Mayor Mahoney) gave everybody in the room his number and said, "If you have a problem in the street, call me, I'll come right there." So, it was really good to see that back and forth with law enforcement. We made it very clear to the law enforcement that we thought they had the hardest job in the world, just because of the crowded cities.

- Mr. Wiley I was very happy to see Hillsdale County law enforcement was represented at the Crisis Intervention Team (CIT) Training.
- Ms. Carlson No comment.
- Ms. Callison Congratulations Maribeth for ten years as CEO. Thank you, too, [Ms. Brown] for the expediency and efficiency you showed while running this meeting. And thanks to the staff for the cupcakes.
- Mr. Poleski I would like to draw members attention to the fact that the Jackson Board of County Commissioners next week in all likelihood will take up some public safety issues, with respect to the potential for a new jail, which I believe would improve facilities for mental health treatment. In our society, the bottom of the slippery slope of mental illness is incarceration. If we can do a better job in our local jail, then that's great. Another thing we will be considering is how to improve our emergency medical dispatch in Jackson County; some of the local fire chiefs have not been happy with that. My impression is that the commissioners are ready to put these two issues in front of voters. Also, millages for both counties was the subject of discussion this past week at the Finance Committee meeting and are we collecting the right amount of millage money? Management committed to looking at that this fall, when it is appropriate. Lastly, with respect to the mass murders seen recently, with all due respect to law enforcement, what is our response when someone exhibits signs of the kinds of things that lead to mass shootings and mass murders? You so often hear "we saw that coming." If this happened in our area, we'd be asked how we addressed any obvious warning signs.

## **PUBLIC COMMENT**

<u>Brad Benzing, Hillsdale County Commissioner</u> – Commended LifeWays for working with bringing people to crisis services. Mr. Benzing also commended Chris Firestone for her work with Substance Abuse Disorders.
