NEW BUSINESS

LW 20-21-040 - Approval for the Subject of Pension Plan Investments in Chinese Communist Companies be Explored Further and a Report Given to the Full Board for Further Exploration and Discussion

To reiterate, the advice in an investment article suggested that no one in the United States should invest in communist owned companies based in China due to the possibility that the investments could be cut off at the will of China's leadership. There are currently upwards of 17% of the pension plan fund invested in international companies. The main questions that arose from this article are: (1) Should LifeWays be invested in communist China; (2) how much of the international investment is allocated to Chinese companies; (3) do the investments made in Chinese companies give LifeWays ownership in these companies; and (4) if #3 is a yes, can the value of LifeWays' investments be negated at the will of China's leadership?

Doug Barber, Principal, Rehmann, stated that LifeWays does not technically own shares in any companies; that is a bit of a misnomer as mutual funds are used as the underlying investment vehicle for the pension plan. Mutual funds are a pooled fund; a report will show the aggregation on how the account is invested. LifeWays has shares in a mutual fund, which are managed professionally, that buy the underlying shares. These shares can be purchased by American Depository Receipt (ADR), which are clones of the actual stocks. The shares can also be purchased on the Shanghai exchange.

Mr. Barber stated that it is possible for communist China's government to negate any investment. It has not happened at any point thus far and Mr. Barber declined to speculate as to whether it would happen in the future.

Of the 17% of the funds invested internationally, 4% (or \$800,000) is split in Chinese markets: 25% (or \$200,000) is invested in mainland China and 15% (or \$120,000) is invested in Taiwan.

Mr. Caswell asked if it wouldn't make more sense to invest even a small amount such as \$200,000 into companies that would not negate LifeWays' assets?

Mr. Barber stated that while 40% of the pension funds are invested in American companies, the mainland Chinese economy is slated to exceed that of the United States in terms of size sometime between 2028-2030. The challenge is should investments ignore a very large market that has a growing and robust middle class. Another consideration is that the mutual funds are overseen by expert managers that navigate geopolitical, economic and corporate risks. These managers have research agencies located in Asia that are able to determine any problems that are brewing on the horizon; this will give the managers time to make portfolio adjustments.

It was reiterated that a full report with pros and cons for investing in Chinese companies would still be appreciated. A full discussion of the investment policy should be included. Also, what are the returns on the 4%?

Mr. Caswell is concerned about the investments of the pension plan on behalf of the staff, some who have been with LifeWays for many years. He wishes to be a good steward with their hard-earned benefit and does not wish to have to scramble to replace any lost funds.

It was noted that the outcomes from the report could incur costs and possible policy change. Any changes in policy may restrict how investments can be made, which may or may not be desirable.

LifeWays is not restricted by federal, state or local laws on how pension funds are invested.

Mr. Barber noted that the report would not incur a separate cost from his firm. He added that permissible investments are governed by the State Constitution of Prudent Investor Rules; generally speaking, that does allow for publicly traded securities. This provides for an appropriate level of risk tolerance via asset allocation, diversification and permissible investments. LifeWays' investments are typically within 65%-67% of stocks via mutual funds with the balance in bonds and cash. The mutual funds are globally diversified, of which emerging markets is part of the sector (this is where the investment in Chinese companies comes in).

Mr. Caswell is not attacking the Rehmann company; he is simply wishing for as much information as possible to be informed on any future implications for the staff pension plan.

Discussion ensued on what the returns are on the 4% invested; whether LifeWays wants to get involved in determining investments; and the aftermath of what would be done once the report is received.

CALL TO ORDER

Chair Jeffrey Peterson called to order at 7:56 p.m. the Public Hearing on Needs Assessment – Jackson County.

Maribeth Leonard, Chief Executive Officer, stated that, in accordance with the Michigan Mental Health Code, each Community Mental Health Services Program (CMHSP) is required to annually conduct an assessment to determine the mental health needs of the residents of the county or counties it represents as well as to identify public and nonpublic services necessary to meet those needs. The information and data concerning the mental health needs of individuals with developmental disability, serious mental illness, and serious emotional disturbance is reported to the Michigan Department of Health and Human Services (MDHHS). This Public Hearing is only one component of data gathering as LifeWays also involves the public and providers in Hillsdale and Jackson counties in various ways to ensure that information is collected from numerous and appropriate sources.

Mr. Poleski noted that the new Jackson County sheriff understands well that many inmates have mental health issues; he would be amenable to any expansion of assistance that LifeWays could provide.

Mr. Woods added that he spoke with both the [Jackson County] sheriff and undersheriff recently; both mentioned how much they appreciated the assistance from LifeWays as well as being given a better understanding of mental health issues. It's impacted their staff and
